The 100 Best Law Firms For Minority Attorneys

Law360, New York (May 19, 2015, 8:56 PM ET) -- For the first time ever, Law360 has ranked the 100 best U.S. law firms for racial minorities, based on the firms' minority representation at the partner and nonpartner levels and their total number of minority attorneys.

These firms buck the trends of the 2015 Law360 Minority Report, which found that while racial diversity has improved at U.S. law firms over the past 15 years, minority representation at all levels of the law firm hierarchy — and particularly among partners — falls far short of law school graduation rates for attorneys of color. Almost every firm in the Top 100 exceeded the overall average among U.S. law firms of 14 percent minority attorneys and 8 percent minority partners.

Leading the way is Palo Alto, Calif.-based Wilson Sonsini Goodrich & Rosati PC, where 26.11 percent of all attorneys and 20.11 percent of equity partners are minorities. New York-based immigration boutique Fragomen, Del Rey, Bernsen & Loewy LLP comes in second, matching its ranking on Law360's list of 100 best law firms for women.

Methodology: Law360 surveyed 289 U.S. firms, or vereins with a U.S. component, about their overall and minority head count numbers as of Dec. 31, 2014. Only U.S.-based attorneys were included in the survey. Firms are ranked based on three factors: 1) the parcentage of partners, both equity and nonequity, who are minorities: 2) the parcentage of nonpartners who are minorities; and 3) the number of minority attorneys at the firm.
